    7. A Fixed Dog Run may be required. Should the run be required, it will need to meet all ordinance setback requirements and be included on this plan.
6. A list of names and mailing addresses of **ALL adjacent property owners**. Names can be obtained from the ownership plats in the Cache County Recorder's Office. Addresses can also be found in the Cache County Assessor's Office. Please include the ZIP Code.
